NB: If last three APAR is not available previous available APAR will be considered.

Terms and Conditions:

- (1) Suitability /competency of the applicant shall be adjudged by nominated Committee by the way of Interview and on the basis of APARs before re-engagement.
- (2) Re-engagement shall be made for a period of one year.
- (3) All the retired Railway supervisors who have not completed 64years & 06months as on date of closing of this notification (to ensure at least 06 months service is available after the re-engagement) shall be eligible for such re-engagement.
- (4) The employees Removed/ Dismissed/ Compulsory retired as a result of DAR action or under Service Review are not eligible for re-engagement. Further employees retired under Safety Related Retirement Scheme (SRRS) / LARSGESS are also not eligible.
- (5) No re-engaged employee shall be allowed to continue in service beyond 65 years of age.
- (6) Preference will be given to the Supervisors retired from the jurisdiction of Project areas.

- (7) Re-engagement shall be subject to prescribed medical fitness for the relevant category.
- (8) The Administration will be at liberty to terminate the services of the re-engaged employees even before completion of his/her term in case their work /conduct is found unsatisfactory by giving a Notice of 15 days.
- (9) The re-engaged retired staff should give a notice of 15 days before discontinuing his/her service.
- (10) The re-engaged employees are entitled only for monthly fixed remuneration i.e. reduction pension from his/her last pay drawn (i.e. Basic +DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay at the time of retirement.
- (11) The re-engaged employees may be permitted off on Sunday and National Holidays. However they may be called for duty on any day including Sundays and National Holidays for which Compensatory Rest may be given later. In addition, Re-engaged staff may be granted eight days leave in a year during engagement in Railway. The accumulated leave will lapse as soon as the contractual period is over and cannot be carried over to next contract (if any).
- (12) Duty pass may be provided for stretch of the journey involved on duty. They may be entitled to 2A duty pass.
- (13) The re-engaged employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.
- (14) The duty hours of the re-engaged employees would be 08 hours or as required. The duty can be changed as per the requirement of works by the administration with weekly off for one day.
- (15) While assigning the duties, the safety and other operational requirement will be adequately considered.
- (16) The retired re-engaged employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
- (17) The TA /DA shall be payable as per extant rules.
