NOTIFICATION

Sub: Re-engagement of Retired Railway Officers (from Pay Levels 10/11/12) in Electrical Department at Metro Railway Kolkata as consultants (electrical).

- I. In terms of Railway Board's guidelines and with the approval of Competent Authority, applications are invited from willing retired Gazetted Railway Officers who were in JAG/SS/JS (Pay Levels - 12/11/10) for re-engagement as Consultant (Electrical) against 3 vacant posts of Junior Scale (Pay Level -10) in Electrical Department of MetroRailway, on fixed monthly remuneration. This scheme for re-engagement of Retired Railway Gazetted Officers shall be valid only upto 31.12.2026.

IV. Eligibility

1. Retired Railway Officers of Electrical Department from JAG/SS/JS (from Pay Levels - 12/11/10) are eligible to apply.

2. Age limit: Maximum age limit for engagement shall be less than 65 years as on 01.01.2025.

3. Medical fitness: Should be medically fit in the appropriate category as done in the Selection from Group 'C' to Group 'B'.

V. How to apply: -

1. Willing Retired Railway Gazetted Officers from JAG/SS/JS Grade (from Pay Levels – 12/11/10) should apply for the post by visiting the official website www.mtp.indianrailways.gov.in.
2. Willing Retired Railway Gazetted Officers from JAG, SS and JS Grade (from Pay Levels – 12/11/10) should submit their application, complete in all respect by emailing to spo@mtp.railnet.gov.in.

TERMS & CONDITIONS:

ANNEXURE - "A"

1. The re-engagement of retired railway Gazetted officers from JAG/SS/JS Grade (from Pay Levels - 12/11/10) as Consultant (Electrical) is for filling up of 03 vacantposts of JS (Level-10) in Electrical Department of Metro Railway, Kolkata.
2. Remuneration: A Fixed Monthly Remuneration shall be admissible which will be arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. Annual increment/percentage increase and Dearness Allowance shall NOT be allowed during the contract period. (Examples for determining remuneration will be as given in Department of Expenditure's Office Memorandum Number F.No.3-25/2020-E.IIIA, dated 09.12.2020).
3. Maximum age limit of the re-engagement shall not exceed 65 years as on 01.01.2025.
4. Suitability/competency of the retired officers shall be adjudged on the basis of last five APARs as per established norms for a DPC by a three member committee of PHODs/CHODs as nominated by the General Manager. While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practice.
5. The period of re-engagement shall be initially for a period of one year and further extendable as per requirement. No retired officer shall be engaged beyond the validityof the scheme i.e. not beyond 31.12.2026. The re-engagement shall be governed by Railway Board's letter nos. 2024/E(GR)I/38/1 dated 29.08.2024 and 08.11.2024
6. The re-engagement of Consultant shall not be considered as a case of re-employment
7. Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service.Accumulation of leave beyond a calendar year will not be allowed nor carried forward in case theengagement is extended. Also, no payment in lieu of unutilized leave will be paid at the time of discharge/expiry of the contract.
8. The Re-engaged officer shall not be entitled for HRA and residential accommodation. However, Transport Allowance for the purpose of

commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. They may be allowed TA/DA on official tour (if any) as per their entitlement at the time of retirement.

9. The designation shall be Consultant (Electrical).

10 The re-engaged officer shall be given responsibilities like inspections, supervision, etc.


11 The re-engaged officer shall not be made in-charge of units like any Branch Officer in divisions nor be given independent charge in any Construction unit. They shall not be given any Financial and D&AR powers. However, they may recommend suggestions on financial and other matters to regular officers.

12 The re-engaged officer shall not divulge any information gathered by him/her during the period of assignment related to the organization to anyone who is not authorized to know/have the same. For this purpose, the Consultant shall sign an Agreement of Confidentiality with the Government of India containing a clause on Ethics and Integrity.

13 The re-engaged officer shall be discharged immediately on joining of Selected Candidates from UPSC or through departmental Selection or for any other reason as per administrative convenience based on the recommendation of PHOD/CHOD concerned.

14 The candidates are requested not to change their mobile and email address as indicated by them in their application form as the communication from Metro Railway Kolkata will be through mobile/email. They are also requested to frequently visit the website of Metro Railway Kolkata as all notices pertaining to the re-engagement of consultants will be displayed in the website of Metro Railway Kolkata (www.mtp.indianrailways.gov.in)
